The Mediterranean Herb Oil Toning Elixirs are formulas rich in functional substances capable of restoring the skin's hydro-lipidic balance after cleansing, reducing the dilation of pores and moisturizing the skin. Formulated with Mediterranean essential oils from medicinal plants all local to the Mediterranean basin, the Toning Elixirs are to be used with the D3 Nano Mist Diffuser device.

**DIRECTIONS:** The MISULA® Mediterranean Herb Oil Toning Elixirs have been specially formulated to be micro-atomized and applied to the face using the MISULA® D3 Nano Mist Diffuser device. First, charge the device for about two hours using the micro USB cable supplied. A red light on the back will show that the device is charging, and it will turn off once the device is charged. Slide off the back cover and unplug the tank's rubber stopper. Fill the tank about 2/3 with water, being careful not to soak the device, as it is not waterproof. Select the desired MISULA® Mediterranean Herb Oil Toning Elixir, and use the container's dropper to add drops of the elixir to the water (about 7 drops). Close the tank securely and replace the back cover. Position the device approximately 15 cm from your face, close your eyes and relax your facial muscles. By sliding down the front cover, the device will automatically start to deliver the micro-particles, depositing them on your skin for 50 seconds. A blue led light will show that the device is on and working. You can repeat this procedure 2-3 times, being careful not to inhale the micro-particles and ensuring that your face, neck and décolleté have been thoroughly misted. Wait a minute or two and then proceed with applying the appropriate MISULA treatments. Once absorbed, the Mediterranean Herb Oil Toning Elixirs provide an ideal base for other serums, creams, or make-up. The device turns off after 60 seconds of use. A flashing blue light means that the device needs to be charged.

Per prima cosa, mettere in carica il dispositivo per circa due ore utilizzando il cavo USB in dotazione. Una spia rossa sul retro indica che il dispositivo si sta caricando. Una volta carico, la spia rossa si spegne. Aprire il coperchio posteriore e il tappo in gomma del serbatoio. Riempire quasi totalmente di acqua, tra **M5.1** (Timo) o **M5.2** (Basilico) che si desidera utilizzare. Il contenitore del prodotto dispone di un contagocce, con il quale è possibile dosare correttamente l'olio, versare nel serbatoio alcune gocce di olio essenziale (da 2 a 7 gocce a seconda dell'intensità desiderata), richiedere il tappo e reinserire il coperchio posteriore. Tenere il dispositivo a circa 15 cm dal viso, chiudere gli occhi e rilassare i muscoli facciali. Spingendo in basso il coperchio frontale, il dispositivo inizierà automaticamente ad erogare le micro-particelle di oli essenziali per 50 secondi, facendone depositare sulla pelle del viso. Una spia blu indica che il dispositivo è acceso e funzionante. È possibile ripetere l'operazione 2/3 volte evitando di inalare le micro-particelle erogate e assicurandosi che viso, collo e décolleté siano stati irrorati. Dopo l'utilizzo, attendere qualche minuto. Una volta assorbito, il prodotto diventa un'ottima base per applicare altre creme, sieri o trucchi. Il dispositivo si spegne dopo ogni 50 secondi d'utilizzo. Il led di colore blu lampeggiante indica che è necessario ricaricare il dispositivo.
